Can I withdraw money?	<p>No, you can't move your money until the end of the 1 year term.</p> <p>We'll contact you before your fixed term ends to explain what happens at the end of the term.</p>	
Additional information	<p>You can cancel your Fixed Saver within the first 14 days of opening it and we'll return your money without interest.</p> <p>The Annual Equivalent Rate (AER) shows how much interest you'll earn after a whole year.</p> <p>We pay 'gross' interest, which means we don't deduct any tax you might owe. You may benefit from a Personal Savings Allowance that varies depending on your other sources of income.
